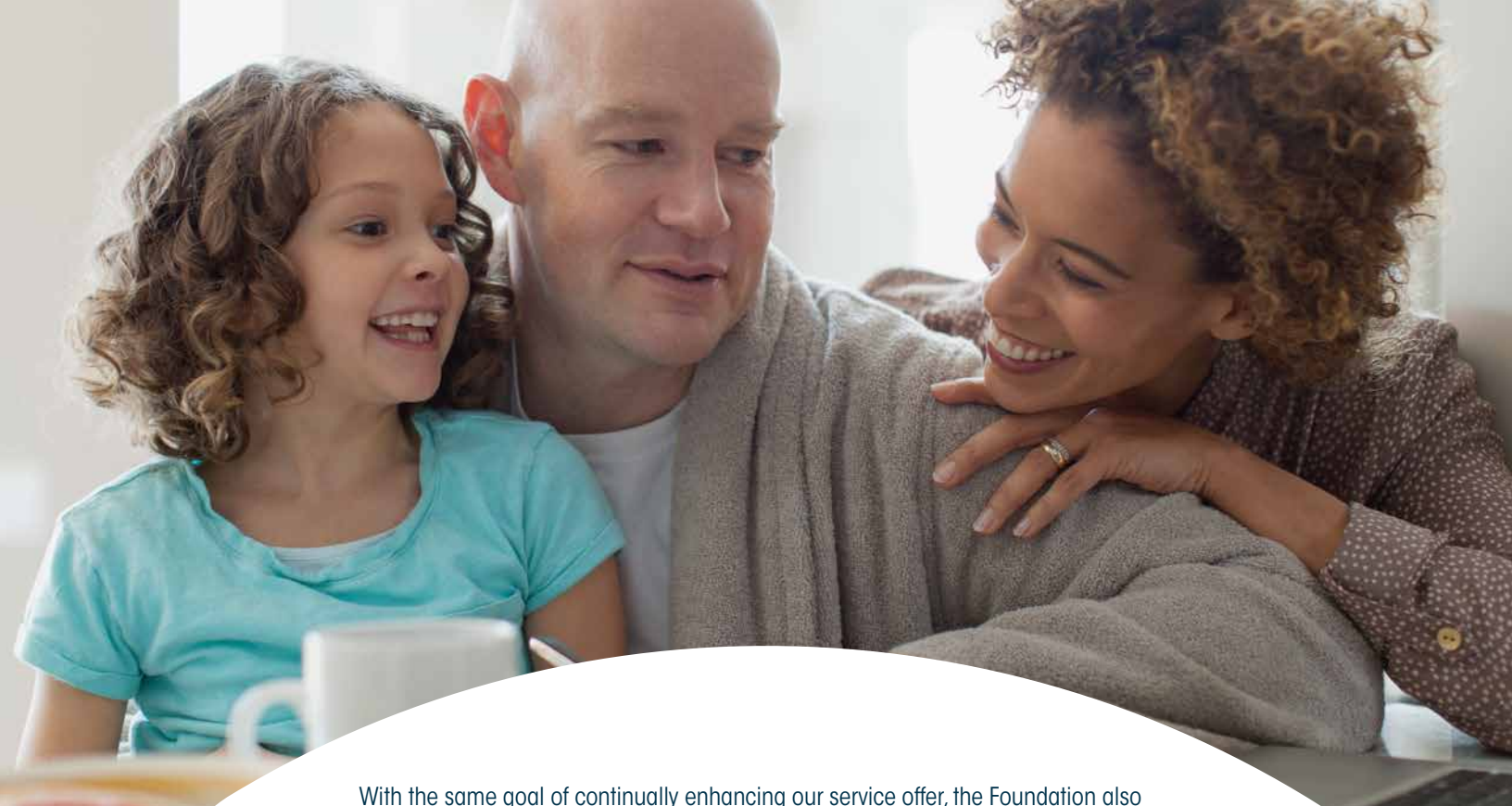
2022 was a year of rebirth and innovation in every corner of the province. At the Quebec Cancer Foundation, it was the time to report on our activities, as our 2020-2022 strategic plan drew to an end. And despite the COVID-19 pandemic that occurred at the outset of this plan, **we are extremely proud to have reached 79% of our objectives.**

To assert its leadership on a provincial scale, the Foundation set out to create various collaborations with healthcare institutions and local partners to improve access to complementary therapies. Today, at least one of our services (and sometimes more) is **offered in close to 30 institutions in Quebec** (including Îles-de-la-Madeleine and the Beauce, Saguenay, and Abitibi-Témiscamingue regions). We must also mention our partnerships with Myeloma Canada, Ovarian Cancer Canada, Espace partenaires en cancérologie, and several other organizations throughout the province, which allow us to offer greater support through our Info-cancer Hotline and telephone peer matching service.

With its objective of introducing increasingly diversified and accessible programs and services to support people with cancer in every aspect of their lives, the Foundation is especially proud of the two **innovative programs it launched in 2022**. After much planning and significant efforts, we were thrilled to implement a financial assistance program, namely the Support program for daily living activities (PAVQ), and a legal assistance program, the latter in conjunction with Juripop. These two programs provide Quebecers facing cancer with a bit of respite so that they can focus on healing instead of other daily concerns. On behalf of all the beneficiaries, the Quebec Cancer Foundation thanks the Fondation Famille Léger for its generous donation of \$25,000 to the Support program for daily living activities, which understands and supports its “raison d’être”.

The organization was invited to present the Support program for daily living activities at the 2022 virtual convention of the PQC cancer program (Programme québécois de cancérologie): *Ensemble, en réseau, pour vaincre le cancer*. This event, with more than 690 participants, had the main objective of sharing the excellent practices present in the Réseau de cancérologie du Québec.

The Foundation also participated in the 5th edition of the *Journée de l’écoute*, an event highlighting the importance of support to actively listen to vulnerable people. In 2022 also, the organization welcomed a social worker within the ranks of our Info-cancer Services.



With the same goal of continually enhancing our service offer, the Foundation also initiated two new collaborative efforts worthy of mention. The first, with the Q-CROC organization, culminated in the launch of Onco+, a free support service to help people with cancer find suitable clinical trials. The other is our partnership with Leucan, to offer the siblings of children with cancer free art-therapy workshops.

This year, over 30,000 stays were extended in the Foundation's 6 Lodges across the province, representing an impressive 50% increase compared to 2021. There were also 237,000 visits to our websites. This aptly but unfortunately illustrates that despite advances in medical technology, cancer is not beating a hasty retreat.

We truly understand how lucky and blessed we are to enjoy the business community's support, which has never ceased to help us pursue our mission. The Quebec business community was particularly fervent in its support of our corporate campaign and its series of Cancerto benefit evenings, events which resulted in over \$1,440,000 being raised on behalf of the Foundation and its beneficiaries.

Overall, with the help and support of the large family that makes up the Quebec Cancer Foundation, **we succeeded in raising \$8.5M in 2022** to make a difference in the lives of Quebecers with cancer. Your donations have an impact that goes far beyond the here and now. The stories on the following pages illustrate how your generosity helps change and save lives. They are stories that are touching, inspiring, and moving, happening every day, because of your unflagging support. Thank you for your loyalty, your dedication, and your generosity.

We want to once again thank the members of the Board of Directors for their support and trust over the past year, as well as the numerous Foundation volunteers and team members. **Together, we make a major difference.**

Juggling entrepreneurship and cancer

Cancer doesn't discriminate. The Quebec Cancer Foundation **offers Quebecers critical support**, regardless of their background, the region from which they hail, their financial circumstances, their age, or the type of cancer they are facing.



Suzan's story

Entrepreneur

Suzan, in her fifties and in a relationship, is a business owner with a store in the Gaspésie region. In May 2015, she was blindsided by a cancer diagnosis.

“ After countless exams over several years, I got the news that I had both lung and bone cancer. It felt like I'd been run over by a truck. I had to shut down my store, because of course I could no longer work, and I had to travel to both Rimouski and Quebec City to undergo treatment. Having no insurance, I watched my savings melt away as the medical costs and side effects grew. I was exhausted, stressed out, and very worried.

To add to our troubles, my spouse then lost his job due to health issues. The only money we had coming in was from our disability pensions, for we did not meet the eligibility criteria of available financial assistance programs. My health deteriorated following the diagnosis and treatments, while our medical bills - especially for dental care - went through the roof. Things got so bad that we had to sell some personal belongings simply to pay for our daily expenses and various medical-related expenses.

We were at our wits' end, thinking we would never be able to get ahead of our financial problems while also coping with the matter of having cancer... Until, in August 2022, my social worker managed to have some of my medical expenses paid by the Foundation's Support program for daily living activities (PAVQ). This was nothing short of a miracle, at a moment when it was sorely needed. ”



Danièle Henkel : turning illness into something useful

Danièle Henkel was struck twice by cancer, first in 2017, which is when she learned that her daughter Amel had been diagnosed with lymphoma, and again in 2018 when she was told she had breast cancer. Thanks to their impressive energy and resilience, along with the support of their families and the help of highly skilled medical experts, both mother and daughter managed to get through cancer.

“ When this type of news comes knocking at your door, not only does your entire world tilt on its axis, but it has a profound effect on all of your loved ones. Being able to receive as much support as possible is a critical factor in getting through this difficult time. Many people, unfortunately, have the impression that they must go through it alone. The Foundation meets needs in this regard by offering a variety of programs and services for patients, loved ones, and healthcare professionals. It also has a corporate support program that can benefit entrepreneurs and employers.

In 2022, the Foundation also launched financial and legal assistance programs that not only bring hope but also enable thousands of people with cancer to focus on their healing rather than worry about their finances. ”

On October 11, 2022, 820 women enjoyed a benefit dinner-show to raise funds for the Foundation at the Centre de congrès de Saint-Hyacinthe. In a warm atmosphere comprised solely of women, the participants present enjoyed a gourmet meal while listening to a musical performance by Guylaine Tanguay.

Close to \$144,000 was raised during this event. The funds gathered allowed for the opening of the Centre de services de Saint-Hyacinthe — where volunteers organize and oversee the lending of equipment and wigs or hairpieces — and the implementation of massage therapy services at Hôpital Honoré-Mercier for people undergoing chemotherapy.



Day of joy (“Journée bonheur”), thanks to La Roche-Posay

On October 27, 2022, La Roche-Posay collaborated with several influencers to create sublime gift bags at our Montreal headquarters. A total of 500 such bags were gifted to our beneficiaries in the Foundation’s Lodges throughout Quebec, who enjoyed special products designed for soothing the skin during the course of cancer treatments. The influencers who participated even wrote an inspiring personal note in each bag!



Successful partnerships for the well-being of people with cancer

In line with our approach focused on the overall well-being of people impacted by cancer and with the aim of providing the latter with various opportunities, we continue to develop and grow our various partnerships across the province. 2022 saw us form a variety of new associations, including Myeloma Canada, Ovarian Cancer Canada, Espace partenaires en cancérologie, and several other organizations throughout Quebec.

The Quebec Cancer Foundation is also proud of having joined forces with **Juripop**, an organization that offers free legal services to people with cancer who find themselves in a precarious financial situation. The overall objective of this partnership is to enable people to focus on healing instead of their financial circumstances.

Another partnership of note is with **Q-CROC**, as it led to the introduction of Onco+, a free support service that helps people with cancer find and register for potentially suitable clinical trials.

And lastly, we joined forces with **Leucan** to offer free art-therapy workshops to the siblings of children with cancer; these activities offer youngsters a place where they can feel less alone and hopefully speak of their experience with others in a similar situation.

Corporate campaign and *Cancerto*

This year, the Quebec business community once again answered our call and helped make the corporate campaign a resounding success! For the year overall, a total of \$1,440,000 was collected.

Spearheading our corporate campaign, the 2022 series of *Cancerto* benefit evenings were attended by over a thousand patrons from Gatineau, Montreal, Trois-Rivières, Sherbrooke, and Quebec. For an entire month, i.e., from November to December, the business community participated in these events to demonstrate its support for people touched by cancer while also enjoying musical performances by the likes of Marc Hervieux, Claude Dupont, the Orchestre du Septième Art, and Florence K. The initiative closed with a performance by Foundation spokesperson Guylaine Tanguay and her guests Maxime Landry and Marjo; this evening alone raised a total of \$290,000.

La marche du Grand défolement

La marche du Grand défolement 2022, presented by Desjardins, has once again shattered existing records. During this 5th year, it raised more than \$460,000.

The invitations respectfully put out by the mayors of Montreal, Quebec, Gatineau, Granby, and Trois-Rivières generated a wave of solidarity. Between September 10 and 24, over 1,000 people (in a total of 134 teams) walked side by side to hail the courage of the Quebecers facing the disease and to raise funds to help.

Overall, 6,020 people from across the province participated in this fundraising event. Since it was created in 2018, *La marche du Grand défolement* has gathered nearly \$1.5 million on behalf of the Foundation.

Peggy's story

PAY IT FORWARD

In 2021, Peggy Bachman received the upending news that she had cancer. As she began her therapy, Peggy felt increasingly alone and physically and morally depleted, despite the support of her family and friends.

After searching for some time, she discovered how the Quebec Cancer Foundation could help. For several months, Peggy benefited from various Foundation services, among them **onco-yoga** classes and **art therapy** sessions. These resources allowed her to regain control of her body, free her thoughts and forge connections with sympathetic workers and people who were facing the same disease and treatment path.

Having gotten stronger and more confident, Peggy decided to raise funds on behalf of the Foundation by participating in *La marche du Grand défolement* in September 2021.

In 2022, Peggy once again joined the ranks of Foundation supporters by becoming the ambassador of the 5th edition in Montreal:

“ I work at Ville de Montréal, and this proved to be an excellent opportunity to support the Foundation at the heart of our amazing city, in a joyful and fun setting. 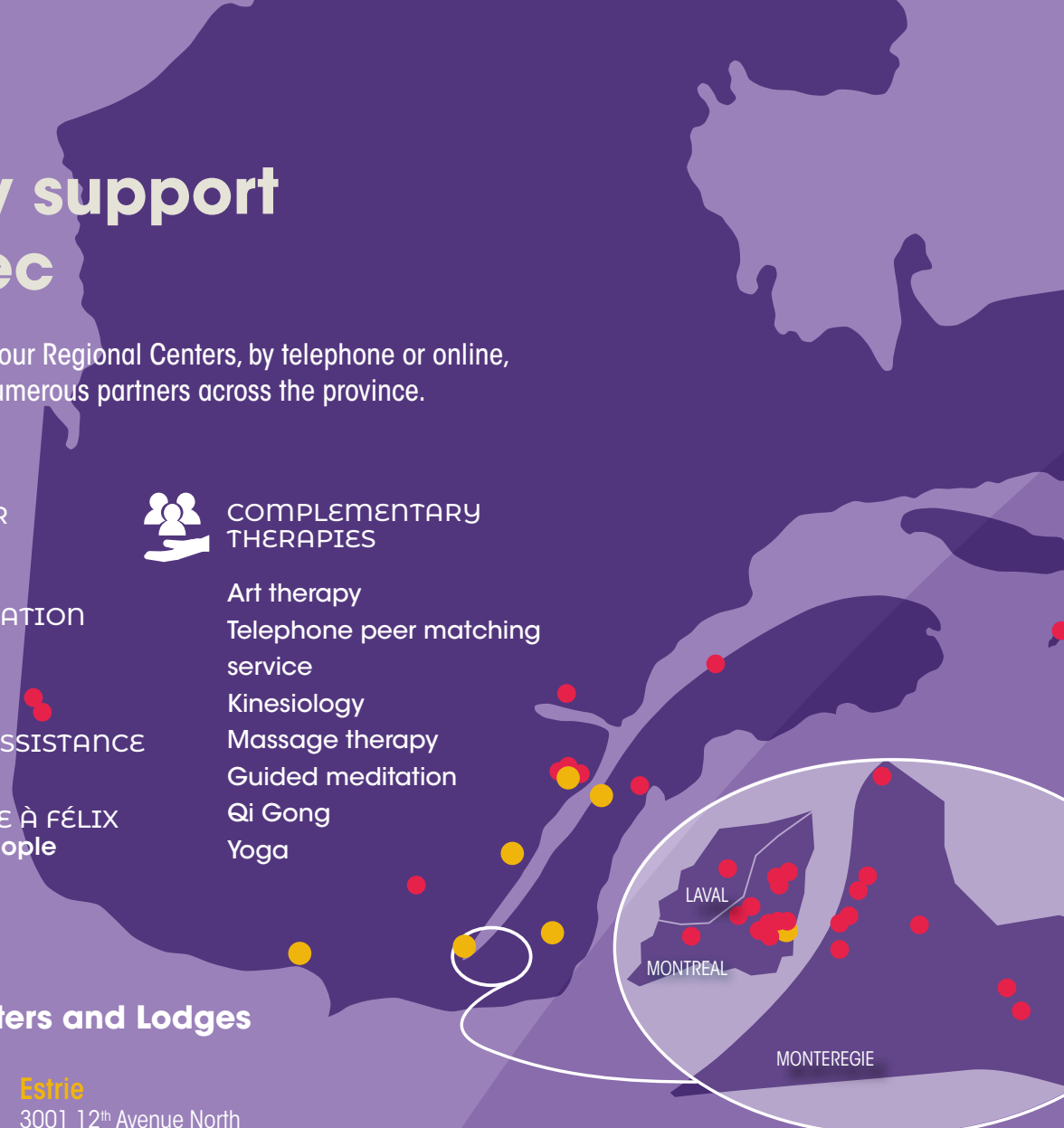
